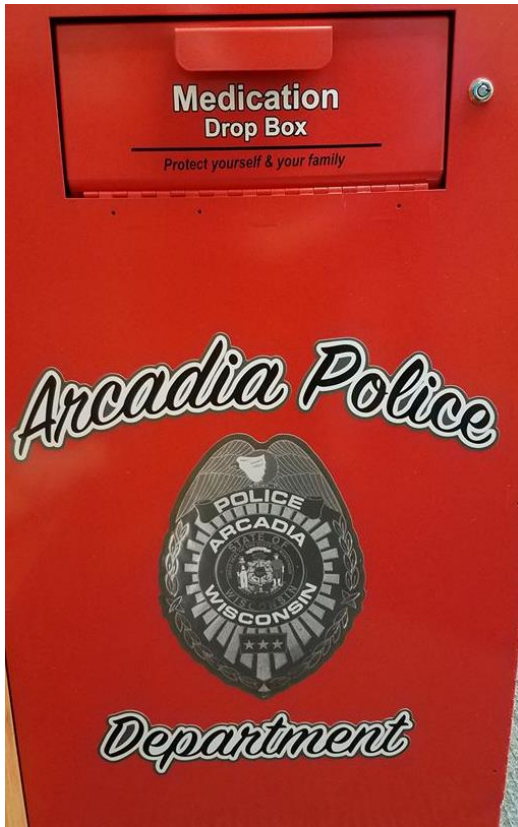

The Arcadia Police Department has been awarded a grant from CVS Pharmacy to combat drug abuse by installing a drug collection unit. The new unit will provide residents with a safe and environmentally responsible way to dispose of unwanted or expired medication, including controlled substances. The unit will be located in the City of Arcadia City Hall, at 203 W Main St Arcadia, and open from the hours of Monday through Friday, 8am to 4:30pm. Drugs can be dropped off with no questions asked.

Items that are accepted:

- Prescriptions
- Prescription patches
- Prescription medications
- Prescription ointments
- Over-the-counter medications
- Vitamins
- Samples
- Medications for pets

Items not accepted:

- Needles (Sharps)
- Aerosol cans
- Inhalers
